#### Scope of Services

The required services include, but are not limited to, the provision of:

- A continuous daily foot patrol and visible security presence in Fish Hoek, covering Beach Road, Main Road, First and Second Avenue.
- Focusing and reporting on hot spot areas and peak hours.
- Supporting the FHBID-led community policing forums and safety campaigns.
- Conduct discreet investigations into security breaches, theft or fraud, always ensuring confidentiality.
- Emergency response and incident management. Immediate response required to Fish Hoek BID security WhatsApp group.
- Monitoring of CCTV analytics and incident reporting software to assist SAPS with investigating and arrests.
- To foster, build and maintain strong relationships with Fish Hoek stakeholders in order the create a secure environment for business owners, investors, residents and visitors alike.

Hours of work: Monday to Friday 06h00 to 18h00

Festive Season: Monday to Sunday 06h00 to 20h00/21h00

Officers required: 3 - 4 officers to patrol daily during these hours

Uniforms: Uniforms to be worn, unless otherwise stipulated

Coverage area: Beach Road, Main Road, 1<sup>st</sup> and 2<sup>nd</sup> Avenue, Fish Hoek

CCTV monitoring: Ad-hoc when required

### Minimum Mandatory Requirements

All bidders must satisfy the following criteria. Failure to do so will result in immediate disqualification:

- Valid company registration documents (CIPC certificate).
- Proof of registration with the Private Security Industry Regulatory Authority (PSIRA) for both the company and its directors.
- Valid PSIRA certificates (Minimum Grade C) for all security officers and supervisors to be deployed.
- Valid SARS Tax Compliance Status PIN or Certificate.
- A valid B-BBEE certificate or affidavit (for EMEs & QSEs).
- Proof of valid Letter of Good Standing with the Compensation Fund (COID).
- Proof of public liability insurance.
- Three (3) contactable references for similar services rendered in the past.
